### Notes about the application form

#### 1. Confidentiality

All information supplied with respect to this application is strictly confidential. No information will be released without your full consent. People are only allowed to work at one of our Collection Points if they agree to keep, in confidence, any personal information released to them. Personal details are stored on computer and the Credit Union is registered under the Data Protection Act. Your admission as a member assumes you agree to these procedures.

#### 2. Personal Information

Your date of birth is required because we offer the benefit of free life insurance.

#### 3. Common Bond

To qualify for membership of **Nottingham Credit Union** Ltd you must live or work within our common bond (Work can be full-time, part time, paid or voluntary). The common bond includes the whole of Nottingham City as well as the urban areas of Gedling and Rushcliffe Boroughs. A map and a precise description is available at all our collection points. **Please give your work address if you do not live in Nottingham.**

#### 4. Proof of Identity

We need proof of your identity as a legal requirement to prevent fraud. We need two forms of identification. One has to be issued by a government department. This could include a benefit book, passport, full driving licence or national insurance number. The other form of identification must include your home address e.g. your last quarter fuel bill or current rent card.

#### 5. Secure Savings

The Credit Union is authorised and regulated by the Financial Services Authority (FSA) just like banks and building societies. Members' money is fully protected through the Financial Services Compensation scheme (FSCS). Nottingham Credit Union is also insured against fraud and theft.
